Mr. SANTOS, Chairperson of the Committee of Supply, reported progress having been made on June 6, 2000.

IN THE COMMITTEE

In the section of the Committee of Supply sitting in Room 254, on Tuesday June 6, 2000, considering the estimates of the Department of Finance, the Honourable Member for Kirkfield Park moved a motion to reduce the Minister's salary.

That due to the recognition that some Manitobans will now pay the highest personal income taxes in all of Canada, the Minister of Finance's salary, budget line 1(a) be reduced to the amount of \$165, equivalent to the increased personal income taxes a family of four making \$60,000 will pay this year as a result of the budget of May 10, 2000.

This motion was defeated on a voice vote, and subsequently two members requested that a formal vote on this matter be taken. Whereupon a counted vote was requested and Members sitting in Room 254 and Room 255 returned to the Chamber. A counted vote was held on the motion, which was defeated (29-20).

Report was received and the Committee of Supply obtained leave to sit again.
