The following petition was presented and read:

Mr. LAMONT – Legislative Assembly of Manitoba to support a change in the Legislative Assembly Rules and the Legislative Assembly Act, which will allow the designation of Recognized Opposition Party status with the election of two MLAs from the same party, provided that the party achieved more than 10% of the vote in the most recent provincial election.

In accordance with the Sessional Order agreed to by the House on September 30, 2019, two sections of Committee of Supply met concurrently with the House in order for the House to consider a Bill.

The House resumed the debate on the Proposed Motion of Hon. Mr. PEDERSEN:

THAT Bill (No. 22) – The Business Registration, Supervision and Ownership Transparency Act (Various Acts Amended)/Loi sur l'enregistrement, la surveillance et la transparence de la propriété effective des entreprises (modification de diverses dispositions législatives), be now read a Second Time and be referred to a Committee of this House.

And the debate continuing,

And Ms. FONTAINE, Mr. MOSES and Hon. Mr. GERRARD having spoken,

And the Question being put. It was agreed to.

The Bill was accordingly read a Second Time and referred to a Committee of this House.
