**THRONE SPEECH PROCEDURE OF THE FIRST SESSION OF THE
THIRTY-SEVENTH LEGISLATURE ON NOVEMBER 25, 1999**

1. At 1:30 p.m., **all Members and guests standing**, the Acting Sergeant-at-Arms, carrying the Mace shoulder high and followed by the Speaker and the Clerks of the Legislative Assembly, enters the Chamber and proceeds along the west side. The Speaker takes post on the east side of the Chamber, the Clerks take post on the west side of the Chamber and the Acting Sergeant-at-Arms returns along the east side of the Chamber to the main entrance where he stands and awaits the arrival of His Honour, the Lieutenant Governor.
2. The Premier, Members of the Executive Council, Military and Civil Aides, and Officers comprising the Officer Escort meet in the Lieutenant Governor's reception room.
3. The Premier, Military and Civil Aides and Officer Escort accompany His Honour from the reception room to the Chamber in the following order:

The Civil Aide on the right
The Military Aide on the left
The Officer Escort
The Premier
The Lieutenant Governor.

4. At the main entrance, the Military and Civil Aides, the Officer Escort halt and turn inwards to allow the Lieutenant Governor and the Premier to advance to the head of the Officer Escort, where His Honour is met by the Mace.

The Lieutenant Governor then, preceded by the Mace carried shoulder high and followed on his left by the Military Aide, and on his right by the Civil Aide, proceeds along the west side of the Chamber to the Throne. The Premier proceeds along the east side and stands on the floor on the east side of the Chamber.

The Military Aide takes up his position on the east side of the Throne and the Civil Aide takes up his position on the west side of the Chamber.

The Officer Escort is positioned on the west side of the Throne.

5. The Lieutenant Governor seats himself on the Throne; the Mace makes obeisance and retires to the east side of the Chamber.
6. The Civil Aide advances from the position he has taken on the west side of the Chamber and, after the usual obeisance on each step, hands the Lieutenant Governor the Speech from the Throne.

The Civil Aide then retires, step by step, and takes up his position on the west side of the Chamber.

Before the Lieutenant Governor reads the Speech from the Throne, he will say "**PLEASE BE SEATED**".

7. The Lieutenant Governor reads the Speech from the Throne.

The Mace then makes obeisance before the Lieutenant Governor and precedes him along the east side of the Chamber to the main entrance, accompanied by the Premier, the Aides and the Officer Escort. **All Members and guests standing.**

8. The Speaker proceeds to the Chair after His Honour has retired from the House.

The Premier proceeds to his seat in the Chamber.

The Acting Sergeant-at-Arms proceeds to the Speaker who is standing before the Chair. The Mace makes obeisance and returns to the Table.

The Clerks take their chairs at the Table.

9. Prayers.

10. The Speaker bows to the Members and says "**PLEASE BE SEATED**".

11. The Premier moves:

"THAT leave be given to introduce a Bill (No. 1) – An Act respecting the Administration of Oaths of Office; Loi sur la prestation des serments d'entrée en fonction, and that the same be now received and read a First Time."

12. The Speaker informs the House that:

"Garry Clark has been appointed Acting Sergeant-at-Arms for the First Session of the Thirty-Seventh Legislature and Dennis Huyda has been appointed Acting Deputy Sergeant-at-Arms."

13. The Speaker then informs the House that:

14. The Premier moves:

"THAT a Special Committee consisting Peter George Dyck, Marcel Laurendeau, Harold Gilleshammer, Hon. Gordon Mackintosh, Hon. Steve Ashton, Tom Nevakshonoff and Nancy Allan be appointed to prepare lists of members to compose the Standing Committees provided under sub-rule 81(1)."

15. The Premier moves:

"THAT the Speech of His Honour, the Lieutenant Governor be taken into consideration tomorrow."
16. The Premier moves:

"THAT this House do now adjourn."
17. The Speaker, preceded by the Acting Sergeant-at-Arms and followed by the Clerks of the Legislative Assembly, proceeds along the east side of the Chamber and exits through the main entrance. **All Members and guests standing.**
