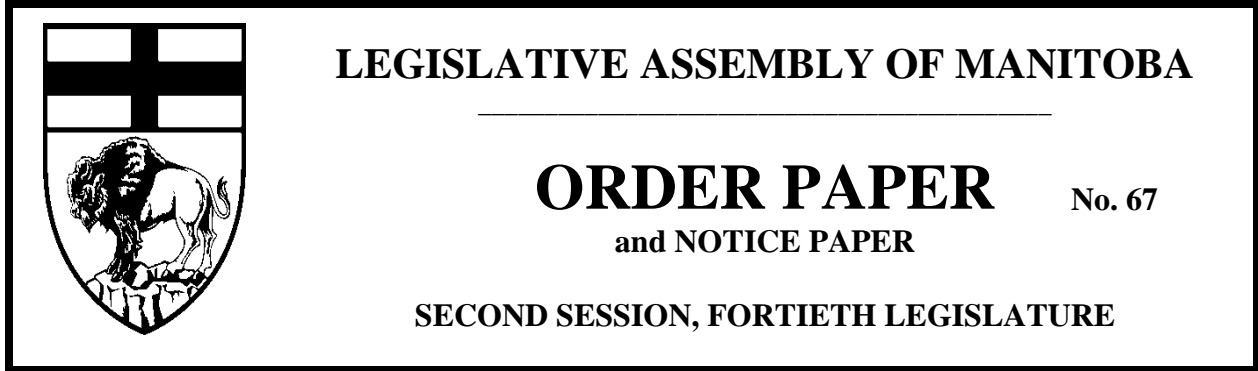

RESOLUTION:

Mr. MALOWAY – Western Power Grid

20. WHEREAS Manitoba Hydro is a key strategic asset for the Province of Manitoba; and

WHEREAS the Premier of our neighbour Saskatchewan publicly announced interest in working toward agreements to buy the clean, renewable Hydro power that Manitoba generates and will be generating in the North; and

WHEREAS to share this power Manitoba needs to continue to develop the Hydro potential through investments in critical infrastructure like the Keeyask and Conawapa generating stations and the Bipole III transmission line; and

WHEREAS a Western power grid has the potential to provide competitively clean energy, increase the security and reliability of energy supply, enhance trade, co-operation, energy market development and help meet climate change targets; and

WHEREAS commitment and leadership from both federal and provincial governments is required to move forward on a cross-border infrastructure project such as a Western power grid; and

WHEREAS now is the time to seize this opportunity to engage in nation building by cooperating with Saskatchewan and Manitoba's other Western neighbours; and

WHEREAS the Canadian Electricity Association has advised that the best way forward for Manitoba Hydro is through building connections in regional markets; and

WHEREAS the Official Opposition has shown no support in moving forward on this important project, part of a long history of failing to invest in Manitoba Hydro.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to continue developing Manitoba Hydro resources and ability to share Manitoba's power; and

BE IT FURTHER RESOLVED that all Members of the Legislative Assembly of Manitoba be urged to call on the Federal Government to support the development of a Western power grid.

PROPOSED RESOLUTION:

Mrs. MITCHELSON – Support for Manitoba Families with Autism

21. WHEREAS the Provincial Government broke a commitment to support families of children with a diagnosis of Autism Spectrum Disorder, including timely diagnosis and access to necessary treatment such as Applied Behavioural Analysis also known as ABA Services; and

WHEREAS the Provincial Government did not follow its own policy statement on autism services which notes the importance of early intervention for children with autism; and

WHEREAS the preschool waiting list for ABA Services has reached its highest level ever with at least 56 children waiting for services; and

WHEREAS the preschool waiting list is expected to exceed 70 children by September, 2013 despite commitments to reduce the list and provide timely access to services; and

WHEREAS the Provincial Government policy of eliminating ABA Services in schools by grade five has caused many children in Manitoba to age out of the window for this very effective ABA treatment because of a lack of access; and

WHEREAS many more children are expected to age out of receiving ABA Services because of a lack of available treatment spaces; and

WHEREAS waiting lists and denials of treatment are unacceptable as no child should be denied access to or age out of eligibility for ABA Services.

THEREFORE BE IT RESOLVED that the Legislative Assembly of Manitoba acknowledge that the Minister of Family Services and Labour and her predecessors have not provided proper supports to Manitoba families with autism; and

BE IT FURTHER RESOLVED that the Legislative Assembly of Manitoba urge the Provincial Government to immediately request that the Minister of Family Services and Labour provide the necessary supports to Manitoba families seeking any form of autism treatment.
