**ELECTION OF SPEAKER FOR THE FIRST SESSION OF THE FORTY-FIRST
LEGISLATURE
May 16, 2016**

1. The Premier and Honorary Aides-de-camp meet in the Lieutenant Governor's reception room.
2. **All Members of the Legislative Assembly** proceed to their seats in the Chamber and **remain standing**.
3. At 10:00 a.m. the Sergeant-at-Arms followed by the Clerk, the Deputy Clerk and the Clerk Assistants enter the Chamber.
4. Her Honour, the Lieutenant Governor accompanied by the Honorary Aides-de-camp and the Premier enters the Chamber and takes her seat on the Throne.
5. The Attorney-General informs the House that Her Honour, the Lieutenant Governor is not prepared to present the Throne Speech until a Speaker has been elected.
6. Her Honour, the Lieutenant Governor will rise from the Throne to retire followed by the Honorary Aides-de-camp and the Premier. **ALL MEMBERS STANDING.**
7. The Election of Speaker is conducted by the Clerk of the Legislative Assembly.
8. The newly elected Speaker is escorted by the Premier and the Leader of the Official Opposition where he/she is invested with the robes of office. The Speaker returns thanks to the House.
9. Her Honour, the Lieutenant Governor, accompanied by the Honorary Aides-de-camp and the Premier enters the Chamber and takes her seat on the Throne.
10. The Speaker addresses the Lieutenant Governor.
11. The Attorney-General indicates to the House that Her Honour, the Lieutenant Governor, will declare the causes of calling this Legislative Assembly on Monday, May 16th at 1:30 p.m.
12. Her Honour, the Lieutenant Governor will rise from the Throne to retire followed by the Honorary Aides-de-camp and the Premier. **ALL MEMBERS STANDING.**
13. The Speaker proceeds to the Throne and recesses the House until 1:30 p.m.

**THRONE SPEECH PROCEDURE FOR THE FIRST SESSION OF THE
FORTY-FIRST LEGISLATURE
MAY 16, 2016**

1. The Premier, Honorary Aides-de-camp and Officer Escort meet in the Lieutenant Governor's reception room.
2. All **Members of the Legislative Assembly** and **invited guests** proceed to their seats in the Chamber and **remain standing**.
3. At 1:30 p.m. the Sergeant-at-Arms followed by the Speaker, the Clerk, the Deputy Clerk and the Clerk Assistants enter the Chamber.
4. Her Honour, the Lieutenant Governor accompanied by the Honorary Aides-de-camp, Officer Escort and the Premier enters the Chamber and takes her seat on the Throne.
5. The Private Secretary delivers the Throne Speech to Her Honour, the Lieutenant Governor.
6. Her Honour, the Lieutenant Governor will say, "**PLEASE BE SEATED**" and then reads the Throne Speech.
7. After completion of the Throne Speech, Her Honour, the Lieutenant Governor will rise from the Throne to retire, accompanied by the Honorary Aides-de-camp, the Officer Escort, the Premier and the Provincial Court Judges. **ALL MEMBERS AND GUESTS STANDING**.

Prior to exiting the Chamber, "God Save the Queen" and "O Canada" will be sung.
8. The Speaker proceeds to the Throne and reads the Prayer.
9. The Premier moves:

"THAT Bill (No. 1) – An Act respecting the Administration of Oaths of Office/Loi sur la prestation des serments d'entrée en fonction, be now read a First Time."
10. The Premier moves the appointment of a Chairperson of the Committees of the Whole House and Deputy Speaker.
11. The Premier moves the appointments of Deputy Chairpersons of the Committees of the Whole House.
12. The Premier moves the appointment of a Special Committee of Seven Persons.
13. The Premier moves:

"THAT the Speech of Her Honour, the Lieutenant Governor, be taken into consideration tomorrow."
14. The Premier moves:

"THAT this House do now adjourn."

15. **ALL MEMBERS AND GUESTS STANDING.**

The Speaker, preceded by the Sergeant-at-Arms and followed by the Clerks, exits the Chamber.
