In accordance with the Manitoba Environment Act (C.C.S.M. c. E125)

THIS LICENCE IS ISSUED TO:

**Ducks Unlimited Canada: "the Licencee"**

for the construction and operation of the Development being a habitat enhancement project flooding approximately 15 ha of existing marshland in a natural water runway located in S 19-13-28W, NW 19-13-28W and SE 24-13-29W, in the Rural Municipality of Archie subject to the following specifications, limits, terms and conditions:


**Specifications, Limits, Terms and Conditions**

- 1) The Licencee shall construct the Development in accordance with the Environment Act Proposal dated July 20, 1992, and the Environmental Impact Statement received by Manitoba Environment on February 5, 1993.
- 2) The Licencee shall construct the engineered works of the Development in accordance with Ducks Unlimited Canada drawing number 535-0586.
- 3) The Licencee shall, prior to beginning construction activities, submit, for the approval of the Director, a report confirming the presence of species listed in Tables I (vegetation), II (mammals) and III (birds) of the Environmental Impact Statement, and listing any additional species which may have been previously omitted.
- 4) The Licencee shall reseed exposed soil with a mixture of native or introduced grasses or legumes.
- 5) The Licencee shall submit to the Director, for the first two years following the completion of construction, an annual report on site inspections made during the calendar year, including data on the extent and species composition of aquatic plants, mammals and birds, and data on water conductivity, hardness and clarity.
- 6) The Licencee shall submit to the Director, for the third year and sixth year following the completion of construction, reports containing a comprehensive inventory of upland and aquatic plants, birds and mammals. The format of the reports will allow direct comparison with the pre-construction report required in Condition 3.
- 7) The Licencee shall ensure that all waste oil products generated by the machinery used in the construction of the Development are collected and disposed of in accordance with applicable Manitoba Environment and legislation requirements.
- 8) The Licencee shall, during construction, ensure that fuel storage areas established for the construction of the Development shall comply with the requirements of *Manitoba Regulation 97/88R* respecting *Storage and Handling of Gasoline and Associated Products*.
