In accordance with the Manitoba Environment Act (C.C.S.M. c. E125)

THIS LICENCE IS ISSUED TO:

THE CITY OF WINNIPEG: The "Licencee"

for the construction and operation of the Development being the Pembina Highway Widening Project in the City of Winnipeg beginning at Rue des Trappistes and extending in a southerly direction to the south City limit bordering the Rural Municipality of Ritchot subject to the following specifications, limits, terms and conditions:


SPECIFICATIONS, LIMITS, TERMS, AND CONDITIONS

1. The Licencee shall construct the Development in accordance with the alignment, configuration and design as described within the *Environment Act Proposal Environmental Assessment Report for the Pembina Highway Widening Project*, filed by the City of Winnipeg, dated November 4, 1993, with the exception that the LaSalle River control weir shall not be incorporated into the final design of the LaSalle River Bridge.
2. The Licencee shall, during final design and construction of the Turnbull Drive and Pembina Highway intersection, consult and reach an agreement with the Manitoba Department of Natural Resources regarding the following:
 - a) the method of rehabilitation of the existing Turnbull Drive intersection,
 - b) the method of land transfer,
 - c) the feature sign relocation at the St. Norbert Provincial Park entrance;
 - d) the landscape treatment of the Pembina Highway frontage with the St. Norbert Provincial Park.
3. The Licencee shall, prior to the final design stage of the LaSalle River bridge, consult and reach an agreement with the Water Resources Branch on the mitigation requirements to protect the groundwater system at the bridge location.
4. The Licencee shall adhere to the Manitoba Department of Natural Resources Guidelines titled *Recommended Fish Protection Procedures for Stream Crossings in Manitoba*.

5. The Licencee shall, prior to April 1 of each year during construction, ensure that disturbed areas at the construction site are rip-rapped to limit erosion and sedimentation in the LaSalle River during the spring freshet.
6. The Licencee shall, from April 1 to June 15 of each year during construction, cease all construction activities that may impact upon the stream channel and which may affect fish mobility and fish habitat.
7. The Licencee shall, during painting operations of the LaSalle River bridge, adhere to the British Columbia Guidelines titled *Guidelines for the Protection of Fish and Fish Habitat during Maintenance Operations*.
8. The Licencee shall, during construction, ensure that fuel storage areas established for the construction of the Development are located a minimum distance of 100 meters away from the high water line of the LaSalle River, and shall comply with the requirements of *Manitoba Regulation 97/88R* respecting *Storage and Handling of Gasoline and Associated Products*.
9. The Licencee shall, at the completion of the La Salle River bridge construction, ensure that the river bank is stabilized and/or rip-rapped from channel bottom to high water elevation at bank-full conditions.
10. The Licencee shall, at the completion of construction, cleanup the construction area and deposit all resulting debris at a registered Municipal Waste Disposal Ground operating under the authority of a permit pursuant to the Waste Disposal Grounds Regulation, Manitoba Regulation 150/91.
11. The Licencee shall, at the completion of construction, landscape and vegetate all areas disturbed during construction with native and/or introduced plant species in order to restore and enhance the site and to protect against erosion.

REVOCATION

If in the opinion of the Director the Licencee has not complied or is not complying with the specifications, limits, terms or conditions set out herein, the Director may revoke, temporarily or permanently, this Licence.
