SUBJECT: Review of Environment Act Proposal for Dunn-Rite Food Products Ltd. – Client File No. 1805.10

The Environmental Compliance and Enforcement Branch of Manitoba Conservation and Water Stewardship has reviewed the Environment Act Proposal submitted by Dunn-Rite Food Products Ltd. (File: 1805.10) and would like the proponent to provide clarification on the following:

1. What is the capacity of the rendering tank and how often is the tank pumped out? With the expansion of the plant, will this tank have capacity to deal with an increased volume in the processing area?
2. Has the proponent conducted any additional sampling and analysis of the wastewater from the plant or is the design specs for the DAF system based solely on sampling conducted by the City of Winnipeg?
3. The report states that the presence of chemicals in the flocculant sludge means that the skimmed solids from the DAF system cannot be included in the waste stream diverted for rendering (p. 4.7). How will this sludge be disposed of?
4. The report states that surveillance of the DAF system performance will occur by reviewing the City of Winnipeg sewer discharge sampling program and supplemented by periodic sampling events conducted by Dunn-Rite (p. 4.9). How often does the proponent intend to sample and what parameters will be sampled for to verify that the DAF system is meeting the desired treatment levels?
5. What kind of maintenance does the DAF system require and how often?
6. Will a chemical storage area be set up as part of this project or is there a pre-existing chemical storage area?
