**Re: Eastview Landfill - Notice of Alteration Approval - Environment Act
Licence No. 3149**

Thank you for your notice of alteration submission dated December 13, 2021 for an alteration to Environment Act Licence No. 3149 originally issued for the construction and operation of the development being a Class 1 Waste Disposal Ground located at 3610 Victoria Avenue East on portions of NW ¼ 17-10-18 WPM in Brandon, Manitoba.

The intent of the alteration is to burn approximately 44,000 m³ of stockpiled mixed wood wastes using an air curtain burner technology.

Upon review of the notice of alteration, I am satisfied that the identified changes in the environmental effects resulting from the proposed alteration would be insignificant. Therefore, pursuant to Section 14(2) of The Environment Act, I approve the implementation of the December 13, 2021 notice of alteration with the following conditions:

1. This approval is for one time use only.
2. The Licensee shall complete the burning operation by April 30, 2022, unless extended by the Director of Environmental Compliance and Enforcement Branch.
3. The Licensee shall notify the Environment Officer not less than five days but not more than ten days of the commencement of burning operation. The Environment Officer may cancel the burning operation at any time.

4. The Licensee shall not locate the air curtain burner within:
 - a) 400 metres of a building area not located on the facility site;
 - b) 50 meters of an active area of the landfill; or
 - c) 50 meters of composting area or an area used to collect flammable materials.

5. The Licensee shall not burn mixed wood wastes unless the burning occurs only:
 - a) in daylight hours;
 - b) under constant supervision; and
 - c) when wind direction and speed will prevent smoke or odour from affecting nearby roads and properties.

6. The Licensee shall regularly remove ashes from the Air Curtain Burner, once the ashes are completely extinguished, and dispose of ashes in the active cell of an approved landfill.

7. The Licensee shall not burn any other products or materials, including but not limited to plywood, composite board or other materials constructed with glues, finishes or preservatives, plastics, composites, rubber, manure, chemically treated fabrics, mattresses, finished furniture, or synthetics.

8. The Licensee shall keep a burn record at the facility or the premises from which the facility is managed for at least five years, and produce a burn record to the director or an environment officer on request. The burn records shall include the following:
 - a) the date, time and duration of the burn;
 - b) the volume and types of waste burned;
 - c) the weather conditions during the burn;
 - d) any deviations from normal operations in respect of the burn; and
 - e) any complaints received respecting the burning of waste at the facility

All other clauses of Environment Act Licence No. 3149 remain in effect.
