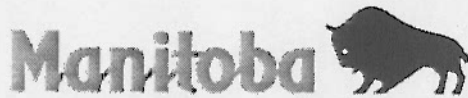

Bruce,

The RM of Hanover will need to apply to the Water Use Licensing Section to increase the allocation on their water rights licence associated with the Grunthal Water Treatment Plant. Depending on how much additional water they apply for, and the potential for third party impacts, Hanover may be required to contract the services of a consulting hydrogeologist to evaluate the potential for third party impacts if additional allocation is to be added to their water rights licence for the Grunthal plant.

MIT has reviewed the proposal under the *Environment Act* noted above and noted above and we have the following comments:

From Regional Operations:

- Under *The Highways and Transportation Act* permits are required from MIT for:
 - any new, modified or relocated access to a Provincial Road or Access Road;
 - any structures (including advertising signs, wells, septic fields, etc.) on, under or above the ground within the 38.1 meter (125 ft) Controlled Area adjacent to Provincial Roads;
 - discharging of water or other liquid materials into a ditch of a Limited Access Highway, Provincial Road or Access Road; and/or
 - placing any trees or plantings within 15.2 metres (50 feet) of the edge of right-of-way of a Limited Access Highway, Provincial Road or Access Road.
- An Underground Agreement will also be required from MIT for any water pipelines within our Right-of-Way and/or Controlled Areas.

From Water Management, Planning and Standards:


- The proposed pipeline will cross beneath one provincial waterway, Tourond Creek. In accordance with Section 14(4) of *The Water Resources Administration Act*, all such crossings of provincial waterways require written conditional Authorization from Water Management and Structures Division, Manitoba Infrastructure and Transportation.
