

# Legislative Library News

## Restoration and conservation of *The Nor'-Wester*


Over the past year and a half, Dalley Froggatt Heritage Conservation Services did restoration and conservation work on the Legislative Library's copy of volume 1 and 2 of *The Nor'-Wester*, Manitoba's first newspaper.

The work included removing the binding of the volume, washing the individual sheets of newsprint, removing tape and stains, and repairing tears and missing pieces of the newspaper.

*The Nor'-Wester* was first published on December 28, 1859. It ceased publication on November 23, 1869.

***Walkable city : how downtown can save America, one step at a time*** / Jeff Speck. 1st ed. New York : Farrar, Straus and Giroux, 2012. 312 p.

Jeff Speck has dedicated his career to determining what makes cities thrive. And he has boiled it down to one key factor: walkability.

The very idea of a modern metropolis evokes visions of bustling sidewalks, vital mass transit, and a vibrant, pedestrian-friendly urban core. But in the typical American city, the car is still king, and downtown is a place that's easy to drive to but often not worth arriving at.

Making walkability happen is relatively easy and cheap; seeing exactly what needs to be done is the trick. In this essential new book, Speck reveals the


invisible workings of the city, how simple decisions have cascading effects, and how we can all make the right choices for our communities.



In 2006, in a hardscrabble part of Pennsylvania that had long lost its allure as a farming and industrial area, geologists began investigating the Marcellus Shale. It turned out to be the richest deposit of natural gas ever discovered anywhere. When his widowed mother was approached about permitting natural-gas exploration on their farm, journalist McGraw had to weigh their need for money against the future prospects of the farmland. Chronicling the impact of the find on his mother and her neighbors, McGraw's research led to this impressively detailed, highly engaging look at issues of energy policy, economics, and sociology that arose when a bucolic town was suddenly faced with the "traveling circus" of energy exploration. McGraw presents a rich history of the economics and geopolitics of energy as well as a fascinating cast of characters, including Victoria, the newcomer environmentalist and former teacher who signed on early and later had regrets; Ken, a cranky hermit skeptical of all parties who later joined ranks with his neighbors to stand up to the oil companies; and Pennsylvania native son Marshall, the sincere young man who signed the locals to leases but worried about the ultimate impact on the community as poor people suddenly found themselves rich. A completely engaging look at how energy policy affected a quiet, rural town.



The oil sands. Global warming. The National Energy Program. Though these seem like modern Canadian subjects, author Mary Janigan reveals them to be a legacy of longstanding regional rivalry. Something of a "Third Solitude" since entering Confederation, the West has long been overshadowed by Canada's other great national debate: but as the conflict over natural resources and their effect on climate change heats up, 150 years of antipathy are coming to a head. Janigan takes readers back to a pivotal moment in 1918, when

Canada's western premiers descended on Ottawa determined to control their own future--and as Margaret MacMillan did in Paris 1919, she deftly illustrates how the results reverberate to this day.

Education governance in the U.S. has been criticized as fragmented, politicized, and bureaucratic among other things and is, the authors and editors note, a significant obstacle to school reform. Structural problems are partially caused by the absence of integration within the four levels of governance, which are Washington, the state capital, the local school district, and the school. The scholars, practitioners, and analysts who have contributed

to the book contend that careful analysis of education's governing system is required to understand the effects of policy changes in areas like standards, testing, and teachers. The contributors identify specific problems, the changes occurring in institutions, lessons from other nations and sectors, and the way ahead.
