


## Spotlight on: Early Board of Education reports

During Manitoba's nascent years, a Board of Education administered 12 Protestant and 12 Catholic school districts. The Library holds copies of the annual reports produced by each of the Superintendents. In 1890, the Legislative Assembly of Manitoba passed legislation creating a Department of Education and abolishing the Board of Education and the Offices of Superintendents that had existed since 1871.



Editors Alexis C. Bunten and Nelson Graburn, along with a diverse group of contributors, frame tourism as a critical lens to explore

the shifting identity politics of Indigeneity in relation to heritage, global policy, and development. They juxtapose diverse expressions of identity – from the commodification of Indigenous culture to the performance of heritage for tourists – to illuminate the complex local, national, and transnational connections these expressions produce.

*Indigenous Tourism Movements* is a sophisticated, sensitive, and refreshingly frank examination of Indigeneity in the contemporary world.





the multiple factors that impact health. Focusing on Canada's health care system, Raisa B. Deber provides brief descriptions of some key facts and concepts necessary to understand health care policy in Canada and place it in an international context.

An accessible guide, *Treating Health Care* unpacks key concepts to provide informed discussions that help us understand and diagnose Canada's health care system and to clarify which proposed changes are likely to improve it - and which are not. This book provides background information to clarify such concepts as: determinants of health; how health systems are organized and financed (including international comparisons); health economics; health ethics; and roles and responsibilities of different stakeholders, including government, providers, and patients. It then addresses some key issues, including equity, efficiency, access and wait times, quality improvement and patient safety, and coverage and payment models. Using analysis rather than advocacy, Deber provides a toolkit to help

understand health care and health policy.



Readers are invited to consider topics such as corporate power, the implications of Canada's economic structure, regional economic differences, the cross-cutting effects of globalization, and the role of interest groups in political and policy processes. In a thoughtful and well-researched style, Hale lays out how the partnership between business and government in Canada is an uneasy one—and one whose capacity to adapt to ongoing change is essential in an uncertain world.

*Truth: A User's Guide* is about the different types of competing truths we face every day in life: how to identify them, why they work, when they are used and misused, and what we can do to guard against them or--when appropriate--to make constructive use of them.

We tend to see the world like Orwell's Winston Smith: "There was truth and there was untruth." Yet the world is far more complicated than that. In a time of "post-truth", when "fake news" is itself the subject of our headlines, it is not "untruths" that we need to worry about. Hector Macdonald reveals and examines one of our greatest collective blind spots: we are all routinely misled by the truth. This is because for any fact, scenario, story, and situation, there are what Hector terms "Competing Truths." Why do Competing Truths matter? They matter because we vote, shop, work, co-operate, and fight

based on what we believe to be true, and what we believe depends in large part on what we read or hear from others. Many of the most sophisticated and influential forms of political, business, and media communication manipulate technically true statements to pull the wool over the public's eyes. Truth is not an absolute--it has its own spectrum. *Truth: A User's Guide* shows us how to cut through the nebulous issue of truth using a scaffold of timely examples. [...]

*Truth: A User's Guide* explores how we can guard against the noise of competing truths, in business, in our personal relationships, and within ourselves, but also how we can use them to our advantage. Written with authority and humour, this is an accessible and illuminating narrative that will find a wide audience among readers in search of understanding why the meaning of "truth" seems to have gone completely haywire.
